FIRM PROFILE



Dr. Hassan Ali Radhi founded the Firm in 1974, under the name "Hassan Radhi Law Firm-Attorneys and Legal Consultants." In the beginning, the Firm's activities were purely local in nature, but soon began to cross international borders in view of the understanding of the need to open new professional and geographical horizons for the office.

Shortly thereafter the Firm's clients began to soar, and it had the opportunity to benefit from the experience of international firms operating in Bahrain. Hassan Radhi Law Firm associated itself with the renowned U.S. legal firm at that time, Coudert Brothers, and together established an international business firm in the name of "Coudert Brothers in Association with Hassan Radhi". The office specialized in business activities of international nature and multi-laws. The association continued for nearly eight years.

Gradually Hassan Radhi Law Firm topped the list of the most reputable and leading law firms in Bahrain and in the Gulf region. With the addition of partners, the Firm changed its name to "Hassan Radhi and Associates-Attorneys and Legal Consultants" in 1994.

FIRM PROFILE

Currently the Firm has 9 Partners. The number of legal professionals presently working at the office, including the partners, is 17, in addition to a group of trainee lawyers, paralegals and articulated clerks. From the Bahraini perspective, this is a large number, enabling the Firm to be a leader in terms of number of legal professionals alongside its technical and administrative staff.

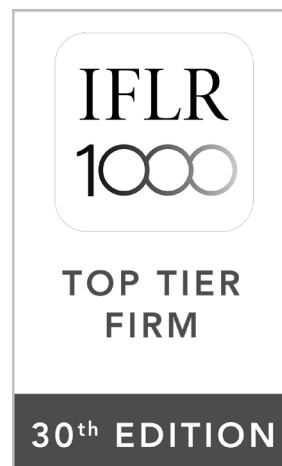

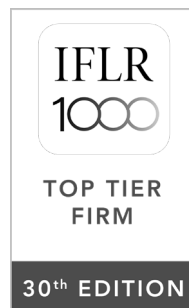
